EVIDENCE OF GRACE

I never really thought that I wanted to get sober, or to stay sober. I believed that only boring, straight-laced nerds did not drink. I also believed that life could not be fun, or exciting, or worth the effort if I did not have my source of power and control; which I believed could only be found in the bottle. I was so delusional that I believed that drinking to excess was the issue, and that if I could learn to control my drinking, and I could seek treatment for my "emotional issues" that all would be well. I would magically become the kind of person that went to work regularly, attired in clean clothes, and made use of proper personal hygiene. I believed that I would suddenly know how to pay my bills, follow through on my commitments and become a stable, trustworthy member of society. Alcohol was not the issue, but rather the amount of alcohol consumed daily was the issue; abstaining in the short term, followed by a method to ensure some control would take care of all the internal and external wreckage in my life. I don't recall believing that I needed a hand up, but a hand out would be nice.

With this attitude and a firmly held faulty belief system, I entered the rooms of AA to find the "method" that I sought. Sobriety would only be a short term affair, and I would learn how to behave. I held close my decision to drink if life became too hard or too painful. Yes, I would stay sober today, but if I were to get fired, or to lose my boyfriend, or God forbid, someone I loved were to die, I WOULD drink. This is the deal that I cut with myself. If the going got too tough I would have a ready made excuse and a course of action. Little did I know that my Higher Power had a different plan for me. My Higher Power recognized that I was dying, and suffering from the pain of loneliness, self deception, self centered fear and a form of moral bankruptcy. My Higher Power's plan was to throw me into the rooms of AA, have total strangers love me for no reason that I could fathom, help me to see my fears, self aggrandizement, dishonesty, and despair. However, these would only be revealed to me with equal amounts of hope, honesty, love and acceptance. The grace of my Higher Power was to teach me that all my secret dealings made with myself were not to be.

When I had one year of sobriety, I began to see that the man that I loved and had been with for many years was a crutch for me, and a hindrance to my sobriety. This man was a lovely person, but we had formed a silent partnership that was comprised of mutual delusion and dishonesty, and the feelings that we had for each other were toxic to us both. I made the decision to live on my own for the first time in my life. This decision was not really my own, but one that was revealed to me by my Higher Power. I needed to learn to love others and myself, before I would really be capable of a romantic relationship. Also, I had much to learn about caring for others, without a self serving agenda. I could not believe that I had the courage to end this relationship, and the power to take a leap of faith to try to live completely alone. I soon saw that it had not really been my doing, but rather the doing of my Higher Power, and his grace.

I had found a high paying executive position in a company shortly after I became sober. I could not see for a long time that the job and all the benefits that were associated with this job were a gift that I had received. It was not long before my mighty ego became so entrenched in the status and the financial payoff, that I forgot this position was an opportunity for growth, and a gift born of God's grace. My ego convinced me that it was surely all about ME! MY brilliance, MY perfection, MY.....whatever. After four years in this position, and with approximately 4 years of sobriety, I lost this job. My ego was deflated, my style of living adjusted accordingly, and my true self was ultimately revealed. The spiritual self, not the ego. God had done for me what I could not do for myself. My Higher Power had stepped in to bring humility, self respect, and immense love for others and myself, and taught me again what exactly mattered in my sobriety. It was time to actively rework the 12 steps of Alcoholics Anonymous.

At five years of sobriety the unimaginable happened. My mother whom I loved more than any one person in my world, died within six months of a diagnosis of throat cancer. HOW could this happen? She was my AA inspiration, my spiritual guide, my hero, the one person who I knew loved me no matter what. My mother had given me immense insight in to God's capability for love, long before I began to understand this source. My mother had gently introduced the AA program to me. My mother was someone that had actually experienced a complete personality change by working the steps. My mother was, for me, a walking, talking reminder of the 10th step promises. HOW was I going to continue recovery, and find my strength without my mother? Once again though magically, wondrously, spontaneously, the absolute grace of my Higher Power began to work in my heart, mind, relationships in and outside of the program. My Higher Power showed me that my mother was ready to move to another plane, that I could help her die. It was

revealed to me that I could myself try to be a reflection of the power of AA, and in doing so, I could love my mother through her passing, and I could also love my AA family, and my family of origin. This was the most amazing, inspirational, loving, faith-filled time I had ever experienced. I absolutely KNEW that I was not the architect of my internal transformation, and that God was again there to carry me through, and more importantly, to help me carry others.

Since the time of my mother's death, many years later, I have experienced too many deaths of beloved friends and family. I have lost jobs, relationships and money. What I now know though, is that I never needed to use my back up plan that I had made in early recovery. I did not have to drink to get through the pain. I did not have to make manifest the idea that there really is nothing so bad that a drink won't make worse. I only needed to stay present, stay open, and allow the lovely Grace of God to guide me through. Yes, I have at times felt the physical ache in my heart of a devastating loss. But rather than run and hide, I can choose to reach outward and allow my Higher Power to continue doing for me what I cannot do for myself. This has been a difficult time for me as of late, as I have watched friends of mine grieve the profound loss of a beloved person in their lives. My prayer is that they will feel God's Grace, and remember the power of the limitless love in the rooms of Alcoholics Anonymous.
