All Words Are Not Equal

In the tens of thousands of words written by Bill W. and the many hours of recorded talks by both Bill and Dr. Bob, and, for that matter, including the first 700 issues of the Grapevine, there is not one four-letter word. Why is that? Is it that neither Bill nor Bob ever used vulgar language? That doesn't seem likely. They lived in the real world. But it does seem clear they didn't include such words as part of their AA practice. They were on a spiritual journey; words had weight and were chosen carefully. And the fact that they chose to open and close meetings with words of

prayer says, even today, that their meetings, now our meetings, are meant to address a higher purpose. The question for us is, "Should we be guided by their example?"

I've been sober for almost thirty years now but I recall clearly that in my drinking days vocabulary had no limits. When alcohol was speaking it usually included plenty of profane language; swear words used for emphasis or exaggeration - expressing anger, astonishment, ridicule, indignation, humor or disparagement. That kind of language, just like liquor once did, still flows easily for some of us. As profane elixers these

words still have a good home in drunken speech - as well as the NFL, NBA, HBO, satellite radio, some work sites and the list goes on.

But is an AA meeting a similar place? When we meet in search of continued sobriety, when we seek a spiritual awakening, when we share our experience, strength and hope, do we honor the memory, the work, and even the genius of our founders by offering our testimony as a curse? Probably not.

Bill's Words on Profanity

When reading any of Bill's writings it is important to understand that he was once a bar-room brawler and had even once lost a job for fighting with a Taxi Driver. He was no stranger to profanity or loud and aggressive behavior. His spiritual experience at Towns Hospital in December of

1934 changed him in such a way that he was never again documented as ever saying an abusive word towards anyone up until his death.

In a November 14, 1951 letter to a member Bill W. wrote: *Respecting obscenity or profanity at AA meetings, I most ardently hold with all you say. It revolts me quite as much as it does you. And I make no doubt that would go for*

99% of us, too. Most off such speakers eventually get policed.

It is probably on A.A., that we carry the principle of tolerance over into license at times. Because there is no personal authority whatever among us, strange to say, all members are pretty reluctant to place a ban on [illegible] of anyone. This is true, even in still graver offenses. Did you know? That in the 40's Los Angles

Had a rule that if you missed two weeks of AA in a row you were expelled? That San Francisco had two warring sides, one that allow attendance at meetings first without working the steps, and the other required that the steps be worked before going to meetings. 12th Step calls were neutral ground.

The wording of Step 12 was first changed in the 2nd printing of the 1st edition in 1941. "as the result of these steps" was changed to "as the result of those steps." Father Ed Dowling expressed his dissatisfaction with the change in his address to the 1955 International Conference (see "AA Comes of Age" pg 256).

The wording of Step 12 was changed back to "as the result of these steps" in 1956 in the 2nd printing of the 2nd edition (there was no Conference advisory action on this).

Excerpt from pages 2 & 3 Experience, Strength and Hope concerning removing profanity from the Big Book and future AA Literature

"Some of the rough edges found in the first edition stories (the use of profanity, for example, references to specific religious beliefs, and several rather disorganized stories) would be smoothed out in those chosen for later editions. When Bill W. began the revision, he laid out some general guidelines: "Since the audience for the book is likely to be newcomers, anything from the point of view of content or style that might offend or alienate those who are not familiar with the program should be carefully eliminated. . . . Profanity, even when mild, rarely contributes as much as it detracts. It should be avoided." In a letter to a prospective contributor, Bill set forth the framework he was seeking: "We are looking for straight personal narratives which describe the drinking history, how the newcomer arrived in Alcoholics Anonymous, how A.A. affected him, and what A.A. has since accomplished for him."

Over the decades the General Service Conference has jealously guarded the AA Message of Hope and has been diligent in to insure that no profanity creeps into any public facing aspect of Literature, Public Service Announcements or AA Conferences.

In the Champaign Urbana area there have been no fewer than two meetings that have over the years had to relocate as a direct result of the use of profanity either before, during or after the meetings. We have to respect our hosts' policies!

As members of AA it is our responsibility to be the example of sober living and to keep Bill's words in mind that profanity rarely contributes as much as it detracts. AA's message is one of attraction and it is far easier to attract with honey than with salt and vinegar.

Do you want to be labeled the person that has quit drinking but still swears like a drunk? Who would see a message of hope and recovery in that behavior?

All Words Are Not Equal

Language has changed in seventy-five years. But the problem is more than the passing of time and a turn to less formal speech between friends and associates. Today there is a pervasive familiarity in our culture and meetings are no exception. Deference of any kind is a sometime thing. The notion of “mixed company” is anathema to many. Today people assume intimacy and informality in almost any setting, maybe especially so in the friendly atmosphere of our meetings. After all, we are a devoted fellowship of alcoholics looking for a better way of life. But we are wrong to believe that our common purpose demands the lowest common denominator of raunchy slang or that cleverness and passion presumably excuse rudeness. Assumptions like these have infected many an AA meeting.

Is it possible that the “Live and let live” slogan has been warped by common misuse to mean, “I will speak as I please and you can just get over it.” At some meetings you could draw that conclusion.

What part of humility and grace do we exhibit by swearing? What kind of gratitude and spiritual growth do we exhibit by cursing our boss, our car, our sponsor? What kind of hope and peace of mind do we exhibit when we verbally punish “they, them and those” who complicate our lives? We don’t show anything very sober by such talk. We can leave those words back at the bar where others are still trying to find their bottom.

Many of our meetings take place in churches and while AA pays rent, we are still guests. Common courtesy insists we not foul their facilities or their faith with our curses.

If we are living examples of the program, we might consider our common welfare. We recite it often enough. With that in mind, why challenge or alienate anyone with endless four-letter adjectives? Are we truly extending the helping hand of AA with a string of expletives? Hardly. Why not display the sobriety and wisdom we pray for? Let it be shown in our self-restraint and heart-felt story telling. Let us demonstrate it with our insights into sobriety and grace by association with other people doing the same thing. As individuals we are not done yet. AA is not done yet. It is all a miraculous work in progress and it’s good. But it can be made better and we can be better.

Bill’s Words on Profanity

Happily, group opinion plus a thorough castigation by John Barleycorn, usually controls in the end. These attitudes may seem unsafe to you. Yet, with some exceptions such as the one you know, they have worked out pretty well.

In November of 1966, Bill W. wrote to an A.A. member from Michigan who asked the question “How do you stop some speakers from swearing at meetings, or do you just go ahead and let them swear?” Bill W. replied: “You raise the question of swearing from the platform at open meetings. At one time or another many perfectly good A.A.’s fall into this way of trying to be impressive. I have, in earlier years, been reminded by my friends that I shouldn’t do this either. It is a rather silly business, and it is offensive to use A.A.’s and especially to friends of A.A. who visit meetings. Of course this is a well known fact. Now when it comes to writing letters of protest to stop this sort of thing—well, I’m afraid I shouldn’t do that. It is my experience that when I intervene in what is a local situation, it only makes matters worse. Why can’t people on the Committee quietly buttonhole the people involved? A good-natured reminder should be enough.

In summary Bill points out how he does not like profanity and that such language can cast a bad light on AA. He goes on to recommend a good-natured reminder or the power of a group conscience as the preferred solution.

Adding a simple line to the opening of the meeting such as “The absence of profanity will offend no-one” will easily set the mood.

The AA Responsibility Statement Explained

"I am responsible when anyone anywhere reaches out for help I want the hand of A.A. always to be there and for that I am responsible." Was adopted at the First International Conference in 1955. The statement was adopted with A.A.'s singleness of purpose in mind, "To stay sober and help other alcoholics to recover from alcoholism." Too often this statement is misconstrued that A.A. should help everyone with every problem. It's God's responsibility to take care of the universe. It is A.A.'s responsibility to help the alcoholic. To this end the Responsibility Statement might be best stated. "I am responsible, when anyone anywhere reaches out for help with the malady of alcoholism I want the hand of A.A. always to be there and for that I am responsible." As we become productive members of society and practice these principles in all of our affairs it is only natural to want to help others in areas outside of A.A.'s singleness of purpose, this is the individuals choice. A.A.'s sole responsibility is to help other alcoholics and has no outside opinions or affiliations.

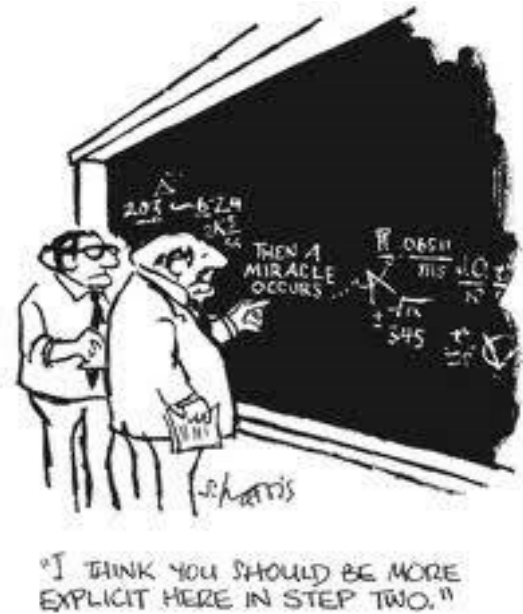
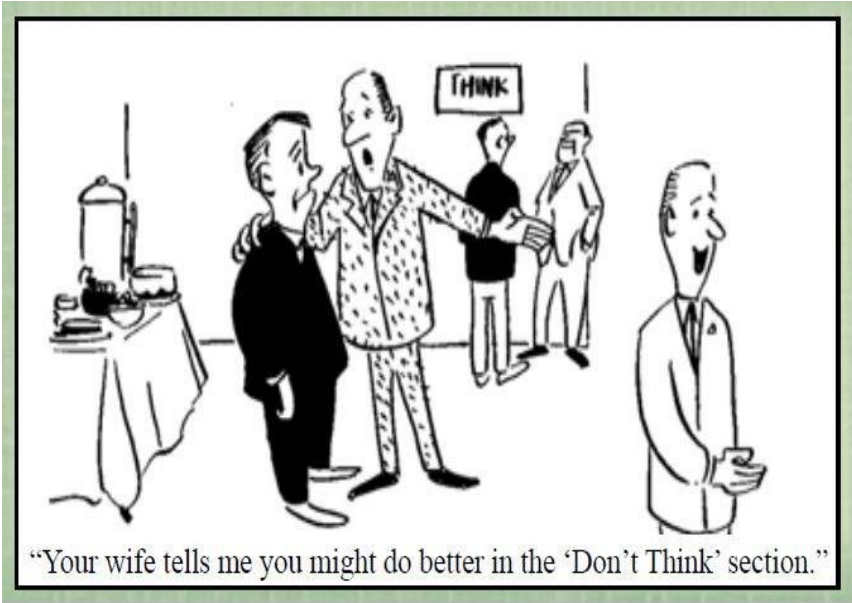
